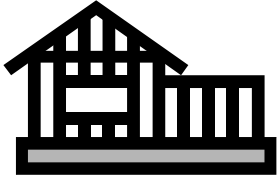

COLLECTION BINS

- Submit a completed permit application. Missing information may delay permit approval.
 - A complete survey of property indicating the location of said collection bin and all structures, lot lines, alleys, fire hydrants, driveways, light poles, traffic control signs.
 - Statement indicating the scheduled times for removal of the contents of the collection bin.
 - A letter signed by the **ORGANIZATION/CORPORATION** setting forth the **Owners** permission to locate the collection bin and who is responsible for maintaining it.
 - Pictures of proposed site.
 - The name, address, email address and 24hr telephone number of LOCAL contact person.

It is understood that approval of permit submitted to the Building Department for review is a conditional approval only and placement shall be subject to compliance with Village of Midlothian Ordinances.

It is further understood that, in the event of conflict between the approved plans and provisions of the ordinances, the ordinance shall be the final authority.
